# **The Challenge**

As the first UK bank to host its core systems fully in the cloud, OakNorth needed a secure, simple and compliant method of sharing confidential information with its team, management and board members.

The bank's challenge was to find a solution that fulfilled four primary criteria:

1 - The solution should be controlled and managed from OakNorth's headquarters in London.

2 - Information needed to be securely stored and protected at all times, while being always available.

3 - Project administrators had to be in control of access and to be able to track all activity.

4 - Compliance with British data protection law requirements.

The solution OakNorth chose needed to offer bank-grade encryption with granular permissions, supported by detailed audit trails and activity reports. At the same time, they wanted it to provide a seamless experience for their users.

## **The Solution**
